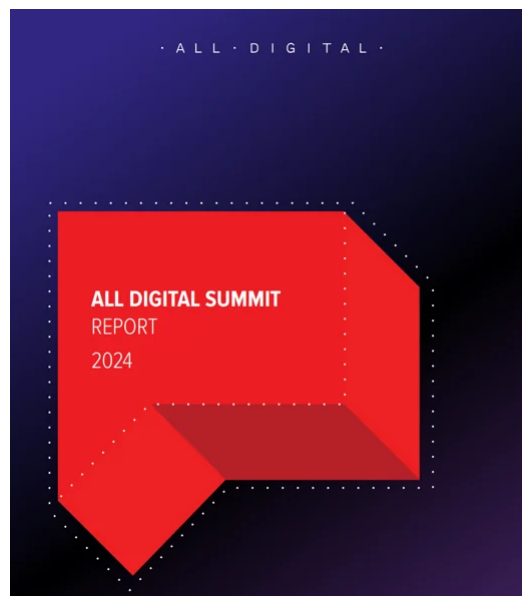

This year the Summit was a three-day event, jointly organised by ALL DIGITAL and Fundacion Esplai, with the collaboration of Plataforma RedConecta, and took place from October 15-17, 2024 in the beautiful city of Madrid.

The main objectives were, on the one hand, generate knowledge, networking and facilitate alliances in the fields of digital skills, employability and entrepreneurship. On the other hand, it aimed at reaching reach agreements on how digital rights are reflected in the different official international documents, as well as to advance in the fight against social exclusion and discrimination, and towards a more conscious and committed citizenship.

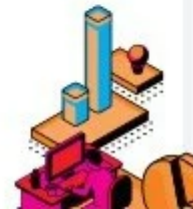

Digital Skills Learning & Development Services for the EU Institutions, Bodies and Agencies

The European Commission seeks external support to **design and deliver training services** focusing on essential and advanced digital skills, along with project management

skills, for statutory staff. Tenders are invited for three areas: essential digital skills (Lot 1), advanced digital skills and data management (Lot 2), and digital skills for project management (Lot 3). Entities must meet specific eligibility criteria, including demonstrating an average yearly turnover of at least EUR 2 million. The submission deadline is 4 December, 16:00 Brussels time. The **EIT Manufacturing Master and Doctoral School** invites proposals to foster innovation and excellence in manufacturing education. The call aims to develop the next generation of creative leaders and innovators. Objectives include expanding partnerships with new Higher Education Institutions (HEIs) and enhancing the programme portfolio with new Master's programmes. Eligible HEIs must be accredited and established in EU Member States, Horizon Europe associated countries, or selected low- and middle-income countries.
