Introduction

The aim of this document is to describe the design and development of the assessment modules for the profiles based on DIGCOMP framework: Entrepreneur and 'virtual office worker'. These modules have been implemented and integrated in the assessment tool of the Pathways for Employ platform.





Implementation

The assessment modules have been designed based on the previous results obtained in the phase of the design of both competences profiles. For the definition of the profiles we focused on real context situations, so for the implementation of the assessment items we followed the same approach. We started with a selection of common scenarios that these profiles use to manage frequently. The for each scenario, we identified the digital competences required to carried out the implicit tasks and taking into account the levels required in the definition of the competence profiles.

For the definition of entrepreneurial assessment module we analyzed the various initiatives that the European Commission is taking place in entrepreneurship and subsequently contrasted the assessment modules developed with the knowledge and experience contributed by the partners in the definition of the competence profile and the network of experts established. For the definition of 'virtual office worker' profile we contrasted the assessment modules developed with the knowledge and experience contributed by all the partners in the definition of the competence profile and the network of experts established.

Results obtained after the evaluation of a user in the assessment modules integrated on the e-assessment platform, have been integrated with the recognition pathways feeding them with the results obtained and issuing the corresponding Open Badges if the criteria is met.

The e-assessment platform has been designed implementing the assessment modules aligned with the 5 areas and 21 competences of the DIGCOMP framework. It assesses the three key elements of the digital competence: knowledge, ability and attitude.

The platform presents different digital challenges to the users to assess their levels in the 21 competences according to the DIGCOMP framework. For each competence profile, the assessment modules have been presented according to the 5 competence areas defined in DIGCOMP:

- Information and data literacy
- Communication and collaboration
- Digital content creation
- Safety
- Problem solving

In the implementation of the assessment modules, different types of assessment items have been selected in order to present to the users a richer and more attractive test, and moreover trying to assess all the components of the digital competence (knowledge, skills and attitude) implementing authentic assessment items which simulate real situations. For example, Multiple choice, True/false and yes/no, Multiple selection or multiple response, Matching, Sequencing/ordering, Hotspot, Short answer, practical exercises, Performance-based questions, simulations and digital challenges,



questions of interaction amongst different services and Likert scale-based questions, etc.

The assessment modules have been implemented and developed in java (J2EE) using different libraries like POI, etc. in order to present digital challenges in the 5 areas where users will be required to develop product outcomes according to the instructions given. We had to automatize the assessment of the digital products and the interactions produced by the users during the tests.

During the test, the marks automatically are presented to the users and the "user history" and "accreditation pathways" are fed with the results automatically. Open Badges have been integrated with the test and are issued automatically and linked to the platform.

5 Assessment modules have been developed for both competence profiles containing at least 3 questions per competence and their levels. The assessment modules have been translated and are available in the partner's languages too.

Furthermore we have designed the concept of the assessment modules in terms of storytelling and real context situations, aligned with the accreditation pathway. That's the reason why we paid special attention to the selection of scenarios that these profiles use to manage in their daily routines. Storytelling has the power to make knowledge (ideas, research and education) more accessible by reaching multiple audiences and he have seen in previous projects that incorporating the storytelling concept in the design increase people interest and improves the engagement. We have focused on employment according to the fifth dimension of the digital competences in the first version of the DIGCOMP framework. Designing the assessment items in storytelling terms will facilitate the contextualization of the digital challenges according to the competence profiles.

Finally, the assessment modules have been developed using images, videos and libraries using open licenses (Creative commons licenses) facilitating the reutilization of the material developed and reducing the costs of the implementation.

ENTREPRENEUR ASSESSMENT MODULE - AREA INFORMATION AND DATA LITERACY (required levels for the area marked in yellow)

Examples of items evaluated in the module:

- Knowledge:
 - Understands how information is generated, managed and made available, and can be found in different devices and media.
 - Is aware of different search engines and understands which search engines or databases best answer to his/her own information needs.
 - o Understands how feeds mechanism works and indexing principles.
- Skills:
 - o Adjusts searches according to specific needs (using filters, agents, etc.)
 - o Can follow information presented in hyper-linked and non-linear form
 - o Can refine information searches and selects controlled vocabulary specific to the search tool
 - o Has strategic information skills for goal oriented activities
 - \circ $\,$ Can modify information searches according to how algorithms are built
 - Is able to adapt search strategies to a specific search engine, application or device
- Attitude:
 - o Has a proactive attitude towards looking for information
 - o Values the positive aspects of technologies for information retrieval

Examples of situations presented in the module:





- 1.1: You search through Google different available software tools / applications and services (You search recommendations/successful business cases in the Web: free VS private tools, which factors you have into account, workers and/or suppliers, distinguish value opinions from invalid/fake opinions, etc.)
- 1.1: The entrepreneur try to decide what is the better tool and system to share documents.
- 1.1: Always it's necessary to share invoices and legal documents with others suppliers like the accountant.
- 1.1: Identify different legal types of companies & the required process. Also, the positive & negatives. (Law for eg: NGO's, search different registers, etc.)
- 1.1. Register your Company online
- 1.2: You have found out a review of the tool that you have selected from a Technical magazine, personal blog, etc. (Analyze and rate other customer opinions about the product/service, Analyze the product distribution in your country or the functional support, etc.)
- 1.2: Evaluate information needs in tools such as Google Docs, Dropbox, Office 365, OneDrive, free accounting systems, Next Cloud, CRM, MIS, etc. or Inside Company communication, example Slack, MS Team, etc.
- 1.2: You want to compare your company's services against the market competitors- how do you stand in offering of products and pricing. For that you need to search available online sources, including other companies' website, digital social media and online sales places.
- 1.3: Searching and localization of confidence sources with relevant and updated information about terms and procedures that your business must follow. In Spain filtering, finding and subscribing relevant information from www.agenciatributaria.es
- 1.3: Searching and filtering financial data about the company market through public entities like Eurostat database. Finding useful data and manage different formats files to make decisions.
- You want to share your company services and offers to a targeted and selected set of potential customers for example hotels that mostly accommodate business travelers. For that purpose you need to find reliable sources of data bases where to identify these companies (hotels) and to choose the right channels how to reach them online.
- You want to compare your company services against the market competitors- how do you stand in offering of products and pricing. For that you need to search available online sources, including other companies' websites, digital social media and online sales places.
- You want to know the main sources where you can find reliable online data of companies operating in particular sector e.g. catering

Examples of items evaluated in the module:

- Knowledge:
 - Is aware of different digital communication means (e.g. email, chat, VoIP, video-conference, SMS)
 - Knows how messages and emails are stored and displayed
 - Knows the functionality of several communication software packages
 - Knows the benefits and limits of different means of communications and distinguishes the most appropriate ones to the context
- Skills:
 - Is able to send an email, write a blog post, an SMS Is able to find and contact peers
 - Is able to edit information in order to communicate it through several means (from sending an email to making a presentation in slides)
 - Evaluates his/her audience and can tailor communication according to audience
 - Is able to filter the communication he/she receives (for instance, sorting out emails, deciding whom to follow on micro-blogging social sites, etc)

- Is confident and comfortable in communicating and expressing through digital media

If not, you can select through the available free or paid VPN services which one you need according to the connection speed needed, which tools you are going to use –only for e-mail or video conferences), etc.
- (Intermediate) When connecting to the selected network, if you are using Windows, you are aware that you should turn off you file sharing and set the connection as Public Connection (instead of Home connection). You know where to find these settings (Control Panel > Network and Sharing Center > Change Advanced Sharing Settings. for Windows and System Preferences > Sharing and Security and Privacy for turning on firewall in iOS). The question in the test can be a task to enable the firewall and add a certain list of software to it. Or choosing between a number of tools the ones which use SSL (like google mail app, skype, Basecamp, etc).
- (Foundation) When you choose the network to which to connect you know that you should ask the staff at the café which is the correct network, because not all networks which your devices detect are safe.
- (Advanced) You know what is browser fingerprinting (a good explanation in this article: <u>http://akademie.dw.de/digitalsafety/your-browsers-fingerprints-and-how-to-reduce-them/</u>) and how to limit it, for example by disabling Java script on your browser. But you are also aware that measures to limit your browser fingerprint can result in limitations of your online experience and you adapt your measures to your needs.
- (Intermediate) You can clear your cookies regularly, and especially after using an unsecured wifi connection.
- (Foundation) You are aware that when you are surfing online, you leave an online fingerprint (a way to identify you according to your online behaviors). You are able to

Identify risks by being cautious opening phishing texts or emails on your device from an unknown source.
 - (Foundation) If you have an iPhone, antivirus is free, therefore your iPhone must be kept up to date when notifications come in. If you have an android phone, you can get free antivirus or you can pay for it. Usually, the free antivirus is enough.
 - (Advance) Use a strong password to protect your laptop and a different one for updates to the device.
 - (Intermediate) Installing antivirus software: Mac comes with its' own ios security and updates, which is free. PC/other laptops, need an external antivirus. Some are free and others have a fee. It is best to research and access your needs as a virtual worker. It is best to find out how much storage antivirus will take up on your PC/laptop, as this can slow down your computer. However, ensure you have an up to date antivirus at all times!
 - (Foundation) Keep your antivirus up to date. If you have an android phone, you can get free antivirus or you can pay for it. Usually, the free antivirus is enough.
 - (Advance) Protect your accounts and information by using different methods of storage/back-up. You need several methods (e.g. Google Drive, Dropbox, IOS Cloud, FolderShare, Huddle, Sharepoint, USB, HardDrive (internal & external), send the information to yourself via email, local server, etc.).
 - (Advance) Turn on your privacy settings, manage only give permission to the team that are working with you. Do not give access to any unknown sources.
 - (Foundation) Identify simple ways of protecting your Cloud data/content, with strong passwords and limiting who has access to the Cloud.
 - (Foundation) Beware of; malicious malware, virus and spam mail/texts etc.

 - (Advanced) Use a Wi-Fi locator device to scan radio frequencies in the local area and detect signal strength of nearby wireless access points. Wi-Fi locators exist in the form of small hardware gadgets designed to fit on a keychain.
 - (Intermediate) Download and use a free app like <u>Wifi Analyzer</u> (for Android), which shows the Wi-Fi strength visually compared to other nearby networks. Similar options are available for iOS. Another option is to use your wireless adapter's own Utility Program. Some manufacturers of wireless

network hardware or notebook computers provide their own software applications that also monitor wireless signal strength.

- o (Foundation) Determine the quality of the WI-FI network signal by locating the icon showing the strength of the signal on your device desktop. E.g., in Windows computer it is usually on the bottom right hand-side next to the clock and it looks like five lines of gradually increasing height next to each other. At foundation level you should be aware that if all five are filled in, the connection is the strongest.
- (Advance) Use the link provided by your service provide to manage the settings of your connection, or use the app, if available.
- (Intermediate) Check the WI FI network settings on your computer.
- (Foundation) Follow the instructions on your router user guide. Do not try to guess how to connect your router. Usually, the instructions are very visual. If the instructions are not in a language that you understand (e.g. if you have just moved to a new country where you don't speak the local language), Check in all the lights on the router are on as written in the router user manual/instructions. If what you see on your router is not the same as what is described in the instructions, identify where is the problem. Restart the rooter. Restart your computer.
- (Advance) Use the link provided by your service provide to manage the settings of your connection, check the firewall, and check if your e-mail server is not blocked by the firewall.
- (Intermediate) Remove your mail account from the mail programme and configure it again, by checking all the details you enter are correct.
- (Foundation) Check if the outgoing server is correct, re-enter your username and password and try again. Restart your mail software and your computer and try again.
- (Advance) Installation of software to link up your laptop to a TV or larger screen with voice input/output.
- (Intermediate) Troubleshoot any issues a day before the meeting and call in early in order for any technical issues to be resolved with any other members of the meeting.
- (Foundation) how to use the wireless microphone and earphones, trial them before the meeting.
- (Foundation) Identify my needs for the meeting to take place: wireless microphone, earphones etc.
- (Advance) Setting up a shared environment (Cloud) to store the project and where updates will take immediate effect when a member of the team is working on it. While also notifying the other team members when another member is working on it.
- (Intermediate) Sharing the document and location of the document/data stored in the cloud.
- (Foundation) Logging into the cloud and accessing the information.
- (Advance) Restart your phone, pull into a nearby service station (like below), etc. And take screen shots of the step by step route to your destination on Google Maps. You can also save a destination on your phone by going to settings. It will not be a 'live map', with traffic updates but it will work.
- (Intermediate) You have no coverage on your phone, pull into a nearby service station, hotel, shop, restaurant etc. and use there wifi network. Be careful, as these are usually 'open' networks (& free to use) and other people may see





your information. You maybe able to write down directions from there as you will lose the signal as soon as you drive away.

- (Foundation) You have no coverage on your phone and your maps aren't working. Print out a physical map before leaving your office, just in case!
- (Advance) If you have not saved your destination to the Tom Tom you can get live updates by connecting your Tom Tom to your phone. This is called, hotspoting off your phone. If your car has it's own internet you can hotspot off this too.
- (Intermediate) Update your Tom Tom,(Sat nav) before you leave for a meeting by connecting to your computer and updating your Tom Tom,(Sat nav). You can also save your destination to the Tom Tom, to avoid delays.
- (Foundation) With the Tom Tom, (Sat nav) your coverage is high, at times it may fail. Again, print out a physical map before leaving your office, just in case!
- (Advance) In car navigation system: this depends on the manufacturer. Your in car navigation may solely depend on your cars sim card (gives internet connection) and/or (you may have both, depending on the manufacturer) a satellite connection, via the tracker on your car. This will give you options and complete coverage. You can also save your destinations in advance of your trip. You can import via email, text etc.
- (Intermediate) You can save your destination prior to travel and use this in the event that you are unable to input coordinates or forget the address. Remember you can access your email via your in car office if you have in built sat nav and internet. You will know this as you will have paid a lot of money for the extra's on your car!!

 - (Advance) Hosting the meeting via your laptop or iPhone/iPad! Best to use a laptop! Sharing your screen and sending documents in parallel is an essential core skill.
 - (Intermediate) Connecting with the group, (calling them).
 - (Foundation) To note, unlike Skype you do not have to download an application, this is already on your ios device. You then need to create a group on FaceTime. It is important to note that FaceTime can only be use on an ios device.





- (Advance) Downloading and choosing security for both devices (phones, laptop etc.).
- (Intermediate) Find out how to securely send information and what information should be sent or given permission to access.
- (Foundation) Strong Passwords, don't use your date of birth, childrens names, pet names etc.
- (Advance) Create your own secure mobile network. With most business internet deals, this allows your laptop, mobile, tablet etc. to pick up safe secure networks that are aligned with your internet deal.
- (Intermediate) Log on to a secure network or own home network. Look for a closed network as open networks are not secure and others may see your work.
- (Foundation) Being able to work on own initiative, while using a secure network.
- (Advance) In a simulate page shows some tools to monitoring information, one of them show updated information in a list with a summary. The others tools show no updated information, not include synonyms and include some post that they don't have quality. Ask about what tool must select.
- (Intermediate) Create a Google alert trough <u>https://www.google.es/alerts</u> for every about personal data protection law with the followings features: frequency one a week, all sources, English language
- (Foundation) True or false, only can I add RSS through feeds tools. Answer: A)

EntreComp mapping

In the following figure from the EntreComp framework¹ are depicted the EntreComp competences as slices of a pie chart. Each slice has a different colour: blue for the competences in the 'Ideas and opportunities' area, orange for those in the 'Resources' area and green for the competences in the 'Into action' area. The slices are surrounded by the three competence rings, which embrace all the 15 competences. This representation underlines that the coupling between competence areas and competences does not have taxonomic rigour. For example, creativity is presented as one of the competences in the 'Ideas and opportunities' area, even though the creative process entails both the use of resources and the capacity to act upon ideas to mould their value.
